

Utility regulators have turned to Saber Partners to help them establish first time utility securitization programs in Texas (\$6 billion in financings in six transactions over six years), Florida (\$1.9 billion in financings in 2 transactions over 10 years), and West Virginia(\$500

million over 4 years). The DC Office of People's Counsel also engaged Saber Partners as their expert witness on securitization matters. In June, the North Carolina Utilities Commission Public Staff chose Saber Partners to help them evaluate a new program for storm securitization in North Carolina.

Mr. Fichera began his career as an associate and investment banking and became a managing director of corporate finance at Smith Barney and Bear Stearns. Then, after 17 years as an investment banker in 2000, he formed Saber Partners with two utility finance executives and a utility counsel.


New Hampshire from 1985 to 1992. Prior to that, he was in private practice in Massachusetts and New Hampshire.
